Conditions of Service:

1) The standard stud fee is \$2500.00 and is payable before the time of mating by cashiers check, money order or cash and includes:

[1] frozen semen collection OR

[2] chilled semen collections and

[3] shipping fees.

~Saturday delivery will be an extra charge.

2) If the stud fee is to be fulfilled by the pick puppy selection from the resulting litter these terms apply and must be agreed to by both parties. Terms of selection are as follows:

If stud owner chooses pick puppy in lieu of the cash stud fee, stud owner will choose pick puppy at six weeks of age or sooner. Bitch owner agrees to notify stud owner immediately after the litter is whelped and agrees to send weekly photo updates as well as weekly weights of all of the puppies in the litter.

It is agreed that stud owner will receive the "Full" AKC registration papers for the chosen puppy at the time said puppy is deemed ready and is shipped to stud owner.

3) Bitch owner will have all necessary progesterone testing done on bitch as timing is very crucial when breeding via chilled semen. Bitch owner will notify stud owner as soon as possible as to when to ship semen. Stud owner agrees to make every effort to ship semen on the date requested. Both parties acknowledge that collection and shipment may not be possible on Sunday because of unavailability of Veterinarian. All shipping containers will need to be sent back to stud owner at the bitch owners expense.

4) All fees are payment for the stud service only and are not a guarantee of puppies. There shall be no refund in whole or part, but a repeat service to the same stud shall be provided at the same bitch's next heat if both are still available; if not available, to a reasonable alternate agreed to by both parties.

5) In the event that no pregnancy results, or there are not at least 2 puppies born, the following applies:

Stud owner will offer a repeat breeding with the same stud dog.

Bitch owner will at that time be responsible for the following fees pertaining to the repeat breeding:

(A) Vet collections and fees

(B) Kits

(C) Shipping fees

The bitch owner has the option to use the same bitch or another **approved** bitch of their choice.

6) If ownership of the bitch changes, right of repeat studding in the event of a litter not resulting from the first studding shall be at the option of the stud dog owner.

7) Owner of the bitch agrees to keep the bitch confined and inaccessible to all other male dogs from the start of her heat cycle until the bitch is fully out of heat.

8) Any veterinary fees incurred due to the testing and actual artificial insemination as well as any complications the bitch may have during the pregnancy or whelping are the responsibility of the bitch owner and are not the stud owners responsibility regardless of the outcome of the stud service.

9) **The following items are needed prior to or at the time of service:**

___ Four (4) Generation Pedigree

___ Current Vaccination and Worming Record

10) The bitch owner agrees that all puppies resulting from this litter will be properly cared for and placed in the proper homes.

11) No puppy resulting from this breeding shall be transferred to puppy brokers, shelters, laboratories, pet shops or their agents.

12) Bitch owner agrees to sell all puppies resulting from the mating as non-breedable pets and will enforce this term by checking the limited registration box on the AKC registration form.

13) Bitch owner is allowed to keep puppies out of litter for use in personal breeding program and register them with full AKC. If Bitch owner transfers puppies registered with full AKC, it is agreed that they will be placed as pets only with NO AKC papers being released to new owner.

14) It is specifically agreed that the stud dog owner is not obligated to sign the application for registration of this litter until the stud fee has been paid in full or in the case of a puppy fee, the stud owner has possession of the puppy or puppies as agreed. Nor is the stud dog owner required to sign the litter application if any of the conditions in this contract have not been followed or if there is a question as to the parentage of the resulting puppies.

We have read and understand the conditions of this contract and both parties agree to the conditions of this contract. This contract shall be deemed a legally binding document.
